

- 2. The purposes for which this corporation is formed and the business enterprises it proposes to engage in are as follows: To own, buy, sell, lease, bond, mortgage and control any and all kinds of real estate. To cultivate and engage in all kinds of general farming, crop raising, stock raising, and to build any and all kinds of houses, barns and out-houses, and to purchase any and all kinds of machinery, and to do any and all things necessary and convenient to be done in the ownership, management and improvement of real estate, and to carry into effect these Articles of Incorporation.
- 3. The principal place of business of this corporation shall be located at the City of Portland, Multnomah County, Oregon.
  - 4. The existence of this corporation shall be perpetual.
